# processing personal data using akelius-languages.com

This privacy policy informs you of the processing of your personal data when using the Akelius webbased version of akelius-languages.com.

## children require verifiable consent from legal guardians

Unless stated otherwise for a particular service, children are not allowed to use the services, and we do not knowingly collect personal data from them.

We define "children" as follows

- residents of the United Kingdom, under 13 years old
- residents of the European Economic Area, under 16 years old or the age required to consent to the processing of personal data in their country of residence
- residents of the Republic of Korea, under 14 years old
- residents of other regions, under 13 years old or the age required to consent to the processing of personal data in that region

For services that do permit child participation, parents or legal guardians ("Parents") must provide verified consent.

Verifiable parental consent is required for the collection, use, or disclosure of a child's personal data.

We will not collect, use, or disclose any personal data from a child if their parent or guardian does not provide such consent.

We may ask a child to provide a parent's email address to request this consent, and the parent's email address will be deleted if consent is not provided within a reasonable time.

In general, information is accessed or stored in the terminal equipment only with consent or if the storage of information in the end user's terminal equipment or access to information already stored in the end user's terminal equipment is necessary to provide, to provide information expressly requested by the user.

# processing of your personal data by akelius-languages.com

In the following, we inform you of the use of your personal data when using the web-based version of akelius-languages.com.

#### general information about the collection and use of your personal data on the website

If you access our website, we only process personal data that your browser transmits to our server.

#### In particular

- IP address
- date and time of access to our websites and time zone differences
- content of the request of the specific website
- http status code or access status
- data volume transmission
- website from which the request comes
- your browser, its language, and the software version
- your operating system and its interface

This is done to enable our website to be viewed and to guarantee the stability and security of the website, art. 6 para. 1 (f) GDPR.

## further data protection information

#### 1. data security, data integrity

We maintain reasonable technical, physical, and organizational measures to protect personal information against accidental or unlawful destruction, or accidental loss, accidental alteration, unauthorized disclosure, or access.

If it is technically possible, your personal data will only be transmitted to us in encrypted or anonymized form.

#### 2. rights to which you are entitled

You have a number of rights as data subject, subject to applicable data protection legislation.

#### right of access

The right of access to your personal data, meaning you are entitled to a confirmation as to whether personal data concerning you is being processed or not.

And where that is the case, access to the personal data and certain additional information on the processing.

#### right to rectification

The right to rectification of inaccurate personal data concerning yourself, and to have incomplete personal data completed.

#### right to erasure

The right to have your personal data erased if

- the personal data are no longer necessary in relation to the purposes, for which they are processed
- you withdraw your consent to the processing and there is no other legal ground for the processing
- the processing of your personal data is not necessary for compliance with a legal obligation, for the establishment, exercise, or defense of legal claims, or archiving or scientific purposes

#### right to withdraw consent

If you have consented to specific processing, the right to withdraw your consent at any time.

The withdrawal of consent does not affect the lawfulness of processing based on consent before its withdrawal.

#### right to object

The right to object and request a new assessment of legitimate interests when processing is based on these grounds.

Akelius Languages Online gGmbH will then make a new assessment and will only continue processing despite your objection, if we can demonstrate compelling legitimate grounds, which override your interests.

#### right to data portability

The right to data portability, meaning you are entitled to receive personal data concerning yourself, which you have provided us with, and to transmit those data to another controller.

#### right to restriction

The right to restriction of your personal data, for example if you contest their accuracy, or if you have objected to the processing as described above.

In both cases this right is applicable during our processing and verification of your request.

You are entitled to object at any time to the aforementioned processing operations, for which there is a legal basis pursuant to art. 6 para. 1 (f) GDPR.

Such requests may be submitted to the contact point listed below.

You are also entitled to the right to complain to the supervisory authority.

#### 3. storage of personal information

We will store personal data only as long as described in this policy above.

Otherwise, as long as it is necessary for the purpose(s), for which it is processed.

If there is no longer a need for personal data, we will erase the personal data, and in any case the erasure will take place in accordance with the statutory provisions.

#### 4. changes to this privacy policy

If we make any material changes to this policy, we will post a notice of the changes that have been made.

You should check this policy periodically to see if any changes have been made recently.

A recent change to this policy can be ascertained by examining the date of entry into force indicated at the beginning of this policy.
